India, UK to hold **FTA talks despite Hardeep Singh** Nijjar irritant

NEW DELHI (UNI): In a signal that other G7 countries are not inclined to emulate fellow member Canada's example of severing trade talks following the murder of Khalistani terrorist Hardeep Singh Nijjar, a 30member delegation from the UK has arrived and will begin the 14th next round of talks for an FTA from Monday. Canada has



broken off talks on a precursor pact to a FTA after its PM Justin Trudeau alleged a potential Indian link in the murder of Nijjar.

Although UK PM Rishi Sunak and Trudeau had spoken last week to discuss the Nijjar row with the former reaffirming the UK's position that all countries should respect sovereignty and the rule of law, there are no signs that London wishes to escalate the issue beyond making this point.

Flash flood: ITBP rescues 56 people in North Sikkim's Chungthang, search continues for 81 missing

cued in North Sikkim's Chungthang, one of the worst affected areas in the flash flood, the ITBP said on Sunday. Among those rescued were 52 men and four women, it said. "In another rescue operation, 56 civilians (52 Male & 4 Female) were successfully rescued via the ropeway made by

the ITBP Rescue Team in Chungthang, North Sikkim," it tweeted. The search for the 81 people who went missing in the flash flood continued. So far, 30 bodies have been found, officials said.

The flash flood triggered by a cloudburst in the early hours of Wednesday affected 41,870 people in four districts of the Himalayan state, with Mangan bearing the brunt of the calamity as a population of around 30,300 was hit by the disaster, according to the Sikkim State Disaster Management Authority (SSDMA). The other three affected districts are Gangtok, Pakyong and Namchi. Nineteen of the

deaths were reported from

Pakyong, six from Gangtok district, four from Mangan, and one from Namchi, the SSDMA said. Special radar, drones and Army dogs have been deployed for the search operations, officials said. So far, 2,563 people have been rescued from different areas and 6,875 people have taken shelter in 30 relief camps set up across the state, most of which have been cut off from the rest of the country.

Gangtok (Agency): Fifty-six people were res- houses and washed away 13 bridges in the four districts of the picturesque Himalayan state.

More than 3,000 tourists stranded in Lachen and Lachung in Mangan district are safe, officials said.

In Guwahati, Chief Minister Himanta Biswa said on Sunday that an Indian Army personnel of Assam, who went missing following the flash flood, has been confirmed dead.

"A tragic loss for Assam as it loses a braveheart in Mitul Kalita of Indian Army, from



Baksa District, in the unfortunate flash flood in Sikkim," Sarma said on X.

Nine army men have been killed in the Sikkim flash flood, which was triggered by a cloudburst in the early hours of Wednesday.

Kalita served in the technical department of the army in Alipurduar. "My prayers for the departed soul & condolences to the bereaved family in this hour of grief," Sarma said.



Poor state of colleges Kupvi college results should be a lesson for HP

THIS is what happens when a government college is opened in a hurry, without the requisite infrastructure and staff, in a bid to reap electoral dividends: with hardly any classes conducted, the students' precious year is wasted as 90 per cent of them flunk the exams. Then Himachal Pradesh Chief Minister Jai Ram Thakur had announced the opening of the college in Kupvi, a remote subdivision in Shimla, in November 2021, with the first session beginning in July 2022, keeping in mind the Assembly polls that were held later that year. Betraying apathy, the college is still functioning from a private building since its site is yet to be finalised, even as the second batch of students is in.

In the first session, 70 students joined BA-I, but no teacher was appointed. This job was left to the Parent-Teacher Association, which could arrange only two private teachers for a brief period. Not surprisingly, the combined strength of BA first and second-year students has dwindled sharply and it is likely to drop further with 63 of the 70 BA-I students failing to clear the exams, though now they have three teachers (the strength is still inadequate).

This situation is symptomatic of the poor state of higher education in Himachal Pradesh. Last year, when the state took the lead in announcing the adoption of the New Education Policy-2020, most teachers were sceptical of the government's ability to do justice to the ambitious programme. They had claimed that the majority of the colleges in the state were running without a principal and there was a shortfall of at least 1,500 teachers. In this scenario, it is doubtful if the NEP-2020, which envisages a multiple choice-based system, learning in local languages, skill development and flexible entry and exit options, can be implemented in letter and spirit.

Rajouri firing It's vital to prevent fratricidal flare-up

SIX months after an Army jawan shot dead four of his colleagues at the Bathinda military station, a Major opened fire and threw grenades inside a camp in Rajouri district of Jammu and Kashmir, injuring three officers. The accused started firing on his colleagues during a shooting practice session and then took shelter in the unit's armoury, from where he lobbed grenades before he was overpowered. The incident is a grim reminder of the simmering tensions in the armed forces that lead to fratricidal or suicidal reactions.

Even as a Court of Inquiry has been ordered, the Army needs to delve deep into the aggravating circumstances in such cases. In the Bathinda incident, the accused gunner had claimed that he was a victim of sodomy and had gunned down the alleged perpetrators to avenge the atrocity committed against him. In July last year, two Army personnel were killed and two others were injured in fratricidal firing after an altercation at an Army camp at Surankote in the border district of Poonch in J&K.

Such incidents, which have a detrimental effect on the morale of the armed forces, should not be kept hidden under a cloak of secrecy. The authorities' reluctance to provide precise information often leads to unwarranted speculation. Bringing out the truth is a prerequisite for course correction. Also, there is a dire need to improve the grievance redressal mechanism and take pre-emptive steps to avert a flare-up. Soldiers work under gruelling conditions, especially those posted in border areas. Acute stress makes them vulnerable physically as well as mentally. The focus should be on addressing their requirements in a time-bound manner and encouraging them to seek psychiatric help or therapy when confronted with mental health issues. When it comes to the Army, an unstable soldier is an unacceptable teammate.

LAST week saw an abrupt end to a bitter, centuries-old land dispute, which also caused several wars. It virtually erased from the global map a small nation which had declared itself a republic after the collapse of the Soviet Union in 1991. What was disquieting was the disinterest of major nations in these tragic developments.

Nagorno-Karabakh, or the Republic of Artsakh, is a disputed Christian-majority territory wedged between Armenia, an ancient Christian nation, and the predominantly Muslim

(Shia) Azerbaijan in the Southern Caucasus region. It traces its history to the fifth century BCE. The area's name originated from three languages: 'Nagorno' is from Russian, meaning a mountainous terrain; 'Kara' is black in Turkish; and 'Bakh' in Persian means garden (bag). Artsakh, which means 'wood', is the ancient Armenian name for this area. Its population in 2020 was 1,40,000.

In the past, this area was a battleground for the Russian, Ottoman and Persian empires. Persian emperor Nadir Shah, the 'butcher' of Delhi in 1739, captured it from the Ottomans in 1735. After his assassination in 1747, his empire split into different Khanates. Karabakh was ruled by a Turkish commander under Iran's titular control. In 1813, Iran transferred Karabakh to Tsar Alexander I after the 1804-13 Russo-Persian war.

After the Soviet Union was formed, Josef Stalin placed the Nagorno-Karabakh Autonomous Region (oblast) with an ethnic Armenian majority within the Soviet Socialist Republic of Azerbaijan due to his suspicion that the latter was getting closer to Turkey.

That did not prevent Azerbaijan from subjecting Artsakh to ethno-religious discrimination to eliminate its Armenian Christian majority and replace it with Azerbaijani Muslim settlers. In 1991, Nagorno-Karabakh formed a new republic when the Soviet Union disintegrated and opened its Washington DC office as the "office of the land of Artsakh".

Azerbaijan did not accept this and Armenian-Azeri clashes ensued. The first Karabakh war (1992-94) resulted in Azeris fleeing from Armenian-controlled territories and Armenians escaping from Azeri-dominated areas. In 1992, the Organisation of Security and Cooperation in Europe (OSCE) set up the OSCE-Minsk Group, cochaired by France, Russia and the US, to restore peace. A ceasefire was achieved in 1994 on Russian initiative, leaving the area under Armenian control; this facilitated a referendum in 2017, when Nagorno-Karabakh decided to proclaim itself as the Republic of

Bitter fighting erupted in 2020 during the second Karabakh war, in which 3,000 Azerbaijani and 4,000 Armenian soldiers were killed. A Russian-brokered peace followed. Armenia agreed to return all occupied territories around Nagorno-Karabakh enclave which it had captured from Azerbaijan.

Even this did not restore peace. Clashes that broke out on Sep-



tember 12, 2022, resulted in the deaths of 100 Armenians and 70 Azerbaijani soldiers. Again, a temporary ceasefire was achieved by Russia, which was already busy with the Ukraine war since February 24 last year. However, this time, Turkey was found to have aided Azerbaijan, which provoked Nancy Pelosi, then Speaker of the US House of Representatives, to travel all the way to Armenia along with US Congressmen on September 19, 2022, and accuse Azerbaijan of being the aggressor.

The 2022 Nagorno-Karabakh war highlighted competing interests of various countries, like we have seen during the Russia-Ukraine war. Though Russia is a military ally of Armenia, it is also a major exporter of arms to Azerbaijan along with Turkey, a NATO member. Also, Azerbaijan is a major exporter of oil and gas to Europe, "where many countries are struggling with supply disruptions due to the war in Ukraine and are trying to reduce their reli-

ance on Russian energy," as the US National Public Radio put it on September 19, 2022.

The present clashes started on September 19 this year when Azeri forces launched an all-out offensive against Nagorno-Karabakh after tormenting the local population with a blockade of food and medicines. This was to suppress what they called Armenian 'terrorist' activities by way of planting landmines which had

killed Azeri civilians and police officers. Azerbaijan claimed to have informed Russian peacekeeping forces in advance, but this was denied by Russia, which said the information came only a few minutes before the attack

A ceasefire initiated by Russia was effective from September 20 on the condition that Nagorno-Karabakh would disarm its forces and hold talks to 'reintegrate' the territory with Azerbaijan. What created panic was the Azeri stipulation that the individuals listed by its government should be handed over to them for trial as 'war criminals'. The exodus started on September 21. By October 2, more than 1 lakh people had fled the Artsakh region. Its capital, Stepanakert, which had a population of 50,000, looks like a ghost city. On September 28, Artsakh President Samvel Shahramanyan had signed a decree that all state institutions of the Artsakh republic would be dissolved by January 1, 2024. Armenia was upset with Russia for letting down Artsakh people when they had all the while considered Moscow as a key ally and security guarantor. They had expected it to protect the status quo and prevent Azerbaijan from gobbling up that area. On Octo-

ber 3, Armenian Parliament voted to join the International Criminal Court; this annoyed Moscow as it would mean agreeing to arrest President Vladimir Putin for alleged war crimes.

However, what was not expected was Israel's continued help to Azerbaijan. In 2020, Armenia withdrew its Ambassador in protest against Israeli supply of weapons to Azerbaijan. Israel considers Azerbaijan as a strategic ally, a critical source of oil and gas, a good market for its weapons and also to keep a watch on Iran.

Jerusalem Post (September 30) and AP News (October 5) reported airlifting of Israeli weapons. Arman Akopian, Armenian Ambassador to Israel, was quoted as saying: "For us, it is a major concern that Israeli weapons have been firing at our people." He described what was happening as 'ethnic cleansing'. People whose forefathers have lived there for 3,000 years are abandoning their spiritual and national heritage.

Political hypocrisy vs social idealism

JITNI abadi utna haq is the Congress' new war cry. Why this sudden change of mind? Why this new slogan for a party that historically distorted the concept of representational politics by offering maximum seats at the high table to the upper castes, particularly Brahmins? Surely, it has to be granted that after nine years, the Opposition is getting its act together by first forming the INDIA bloc and then unveiling its grand idea. The Opposition that has been floundering with just the anti-Modi tirade and accusations of crony capitalism favouring Adani as its staple has now found a magnificent mojo — caste census.

The headline-stealing raids and arrests of journalists, a news portal promoter, an Opposition MP and others are all alleged to be signs of desperation of the Union Government that is buying time to respond to the Bihar caste survey, whose findings were released on Gandhi Jayanti. Whether the government is jittery or not, the survey is definitely a new attempt by the Opposition to grab the political initiative and set an agenda for the 2024 polls, forcing the BJP to either acquiesce or respond. But will it work? Is it enough to stop the Modi juggernaut and defeat him?

The old Bihari prescription of the identity drug to treat electoral deficiencies worked 30 years ago because the feudal edifices in the Gangetic plains were still intact and the Congress leadership was a mere extension of this feudal overlordship. It was a historical necessity to break the feudal order that had destroyed the socio-economic potential of the largest number of Indian citizens, reducing them to subhuman poverty and making them pedal rickshaws in Delhi or toil in Punjab's fields or Gujarat's factories. But that was 30 years ago. Brahmins have stopped ruling the Gangetic plains since then.

And it was a mere extrapolation of a social change that had already occurred in South India: the transfer of power from the empowered to the less privileged but dominant castes. The major difference in the southern and northern experiments has been the emergence of the numerically superior Yadav caste as the primary beneficiary of social change in Bihar and Uttar

The caste wheel, obviously, cannot be reinvented minus honest spokes of representation. In fact, Chief Minister Nitish Kumar's grand idea will fail in Bihar itself on the touchstone of representation. According to his own survey, Nitish's caste Kurmi is just 2.87 per cent of the state's population. So, if one

goes by the jitni abadi utna haq principle, only a Yadav should be the CM of Bihar, for Yadavs account for the largest slice of 14.26 per cent of the population. So, Tejashwi Yadav should immediately be promoted to CM and Nitish does not even qualify to be Deputy CM because other castes have a greater share in the population. Now, if the electorate is divided not just among jatis, which could be fractious, but along caste groups — like general category, backward caste, extremely backward caste, scheduled caste and scheduled tribe — Nitish again does not qualify because he does not belong to the largest group: extremely backward caste.

Political hypocrisy cannot prop up social idealism. The caste survey will work as a political tool only if on its basis Nitish resigns and hands over the reins of his government to a member of an extremely backward caste or a Yadav. You

ward-caste leader in India who is crying hoarse for a national caste census. For instance, Tamil Nadu CM MK Stalin will

push to sound credible. If your own community is as numerically insignificant as Brahmins, the caste census won't be an effective anti-Brahminical propaganda tool.

Purely on the relative strength of the caste of birth, Nitish's right to become CM of Bihar is less than that of a Brahmin (3.65 per cent) or a Rajput (3.45 per cent). And this gets worse in the case of the Congress. If the Congress seeks to pursue the abadi-haq slogan, it will have to first abandon the Gandhi family, which really does not represent any caste other than cosmopolitan India. Congress president Mallikarjun Kharge is from a scheduled caste and not from the numerically more superior OBC grouping. The most visible face of the party, Jairam Ramesh, is a Brahmin and hence disqualified, and so are all the important general secretaries and the treasurer of the party. Backward caste politics can have two objectives — to grab power for the single largest caste group, or to attack the BJP as a symbol of Brahminical hegemony of the old feudal order. And both have run their course. For one, the OBC politics has become family enterprises in Bihar, UP, Tamil Nadu and elsewhere and is no longer considered emancipatory; and more importantly, the Sangh Parivar has owned up social engineering as an electoral ploy more assiduously than the Congress or the Left, crafting its own OBC leadership with Modi as a better example than anything that the Opposition can offer. Modi's community, the oil-pressing Teli, is almost as big as Nitish's own caste even in Bihar. Those who conjured up the moth-eaten Bihari formula should at least have remembered the Punjab experiment that failed. Charanjit Singh Channi represented the single largest caste grouping and yet lost the elections from both seats he contested; for, the people wanted change and not caste. When served with dollops of double standards, identity politics reeks of regressive opportunism.

Nepalese students studying in Israel have been injured and 11 are still missing after Hamas militants attacked a farm, Foreign Minister N P Saud said on Sunday.

The minister said casualties are feared among the missing students studying in the southern part of Israel.

Israel witnessed a surprise and unprecedented attack by the Hamas group, which rules the Gaza Strip, in its southern parts on Saturday morning.

At least 600 people, including soldiers, have been killed and more than 1,900 injured in Israel-the deadliest day for the country in at least 50 years.

In the Gaza Strip, there are nearly 300 deaths and about 1,500 wounded in Israel's

counterattack, media reports said on Sunday.

"Contact could not be established with 11 Nepalese students and heavy casualties among them are feared," Foreign Minister Saud said. "We are trying to ascertain the exact number of casualties," he added.

California governor vetoes anti-caste discrimination bill, terms it 'unnecessary'

WASHINGTON (Agency):

California Governor Gavin Newsom has vetoed a landmark anti-caste discrimination bill recently passed by the state assembly, terming it "unnecessary" and underlining that laws to ban caste-based discrimination already exist in the US state.

The governor's move has been welcomed by a large segment of the Indian-American the bill based on the same argument.

"In California, we believe everyone deserves to be treated with dignity and respect, no matter who they are, where they come from, who they love, or where they live," Newsom said in a statement on Saturday. "That is why California already prohibits discrimination based on sex, race, colour, religion, ancestry, national origin, disability, gender identity, sexual orientation, and other characteristics, and state law specifies that these civil rights protections shall be liberally construed. Because discrimination based on caste is already prohibited under these existing categories, this bill is unnecessary," he said. For this reason, Newsom asserted that he "cannot sign" the bill, known as 'SB403', which was recently passed by a large majority by both the House of Representatives and Senate of the California State Assembly. narratives," it said.

Afghanistan earthquake: Death toll rises to 2,000; 6 villages destroyed, hundreds of civilians buried under debris

from strong earthquakes that shook western Afghanistan rises to 2,000, said a Taliban spokesman, in one of the deadliest earthquakes to strike the country in two decades. A powerful 6.3-magnitude earthquake followed by strong aftershocks killed dozens of people in western Afghanistan on Saturday, the country's national disaster authority said. Abdul Wahid Rayan, spokesman of the Ministry of Information and Culture, said the death toll from the earthquake in Herat is higher originally reported. About six villages have been destroyed, and hundreds of civilians have been buried under the debris, he said while calling for urgent help. The

reports that some people may be trapped under collapsed buildings," the UN said.

The United States Geological Survey said the quake's epicenter was about 40 kilometers (25 miles) northwest of Herat city. It was followed by three very strong aftershocks, measuring magnitude 6.3, 5.9 and 5.5, as well as lesser shocks.

At least five strong tremors struck the city around noon, Herat city resident Abdul Shakor Samadi said.

"All people are out of their homes," Samadi said. "Houses, offices and shops are all empty and there are fears of more earthquakes. My family and I were inside our home, I felt the quake." His family began shoutturn indoors. The World Health
